Freedom of Information request

- 8)Are you using the Office 365 suite? If so, which applications from the suite are in use?
- 9)Which team and/or individual(s) are responsible for your intranet's procurement within the organisation?
- 10)Is your Active Directory hosted on-premise, or in the cloud?
- 11)Could you provide us with a link to your Digital Workplace Strategy?

Response

2. The HTA uses a piece of software called Claromentis.
3. Development of the current HTA intranet began in February 2020.

4. The HTA's intranet contract is due for renewal in February 2021.
5. This is not applicable. The HTA does not currently have a designated annual intranet budget.
6. No. The HTA does not share its intranet/IT services with other organisations.
7. The Communications Team collectively is responsible for managing the intranet internally.
8. Yes. The HTA is using Office 365 and uses the following applications: Office Suite, Teams, Stream, OneNote, Outlook, OneDrive, Planner, To-Do, Power BI, MyAnalytics, SharePoint Online.
9. The Head of Communications is responsible for intranet procurement.
10. The Active Directory is hosted by Hybrid.
11. This is not applicable. The HTA does not have a "Digital Workplace Strategy".
