9)Which team and/or individual(s) are responsible for your intranet's procurement within the organisation?

10) Is your Active Directory hosted on-premise, or in the cloud?

11)Could you provide us with a link to your Digital Workplace Strategy?

Response

- 6. No. The HTA does not share its intranet/IT services with other organisations.
- 7. The Communications Team collectively is responsible for managing the intranet internally.
- Yes. The HTA is using Office 365 and uses the following applications: Office Suite, Teams, Stream, OneNote, Outlook, OneDrive, Planner, To-Do, Power BI, MyAnalytics, SharePoint Online.
- 9. The Head of Communications is responsible for intranet procurement.
- 10. The Active Directory is hosted by Hybrid.
- 11. This is not applicable. The HTA does not have a "Digital Workplace Strategy".
