Response

The HTA along with other Arms Length Bodies were mandated to locate in offices under the Crown banner. In 2010, the HTA moved into its current premises at 151 Buckingham Palace Road, London, SW1W 9SZ.

The HTA agreed a contract through the Government Property Agency (GPA), who deliver property and workplace solutions across government by managing central government property, including estates and facilities management. Therefore, any consideration in relation to our organisational responsibilities under the Climate Change Act 2008 are managed through the GPA and accounted for within our overall costs for the estates and facilities they provide.
