Freedom of Information request

Thank you for your request for information under the Freedom of Information Act (FOIA), which was received by the Human Tissue Authority (HTA) on 18 January 2021. Your email outlined the following request:

Previously in an email dated 20-2-2014 you provided a response to a Freedom of Information Act request where you detailed the location, incident classification and summarised description of HTARIs for the 2013 calendar vear.

Could you provide me with a similar response for HTARIs that took place in the 2020 calendar year?

Response

The HTA holds information about HTARIs reported to have occurred in 2020.

In considering your request for this information, we conclude some of the information we hold is exempt from disclosure by virtue of the absolute exemption under section 21 of the FOIA. This is because this information is easily accessible by other means.

- Since July 2020, we produce quarterly reports detailing information for all incidents that have been investigated and closed. These reports are published on our website.
